

Sealed quotations are invited for the disposal of condemned "Misc. Items like Machinery & Equipment, Furniture etc."

These items are available for sale on **"AS IS WHERE IS"** basis. Sales Tax as per the rules have to be paid. The items are open to inspection for interested parties between **10:30 AM to 1:00 PM on 21.07.2014** in NCDC premises.

The quotations duly wax sealed, prominently subscribed Quotation for "Disposal of condemned Misc. Items like Machinery & Equipment, Furniture etc." and addressed to The Condemnation Committee, NCDC, 22, Sham Nath Marg, Delhi-110054, should reach the Stores Office, NCDC **on or before 12:30 PM on 23.07.2014** and an entry to be made in the Register kept in the Stores Section before putting the Bids in the Tender Box. The quotation will be opened up on the same day i.e. **on 23.07.2014 at 1:00 PM** in the presence of the interested parties. The offer should be accompanied by **EMD of Rs. 20,000/-** in favour of "Director, NCDC" in the form of PO/DD payable at Delhi. However, **The bid will be responsive/considered only, if the quoted prices are more than the Sealed Reserved Prices with the Institution (for acceptance of bid it is essential)**. Bids will be awarded on highest basis. Further, Tax/VAT @ 12.5%, Transfer Fees and Levies shall have to be paid extra (as app.) by buyer and the same must be mentioned clearly while quoting the bid.

After announcement of the highest bid, the successful tenderer has to deposit 25% amount in cash immediately and remaining amount in form of PO/DD in favour of Director, NCDC, Delhi within 24 hours. In case the successful tenderer fails to deposit 25% amount in cash immediately after announcement of the highest bid quoted, the EMD deposited would stand forfeited. The EMD of the unsuccessful bidders would be returned on the maturity of the said bid or say within 7-10 days.

After depositing the 100% amount, the successful tenderer must lift the items from the NCDC premises within **two working days**.

It is the responsibility of the tenderer to see that the completed tender documents, are dropped in the Tender Box kept in Stores Section by the time and date stipulated for opening of tender, failing which the bid would be considered late and rejected. Mere handing over the tender/bids documents in Stores section or at any other counter/room/section or person cannot be considered as submission of bid and shall not be entertained. The quotations, which are not received duly wax sealed, mentioning this office letter number and last date of receiving will not be accepted. Firm shall subscribe on the envelope **"NOT TO BE OPENED UP BEFORE 1:00 PM on 23.07.2014"**.
